### 3. HAZARDS IDENTIFICATION

---

**Main hazards:** Contact with acids liberates very toxic gas.

### 4. FIRST AID MEASURES (SYMPTOMS)

---

**Skin contact:** There may be mild irritation at the site of contact.  
**Eye contact:** There may be irritation and redness.  
**Ingestion:** There may be irritation of the throat.  
**Inhalation:** No symptoms.

### 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Wash immediately with plenty of soap and water.  
**Eye contact:** Bathe the eye with running water for 15 minutes.  
**Ingestion:** Wash out mouth with water.  
**Inhalation:** Consult a doctor.

## 5. FIRE-FIGHTING MEASURES

<b>Extinguishing media:</b>	Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.
<b>Exposure hazards:</b>	In combustion emits toxic fumes.
<b>Protection of fire-fighters:</b>	Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

## 6. ACCIDENTAL RELEASE MEASURES

---

<b>Personal precautions:</b>	Refer to section 8 of SDS for personal protection details. Turn leaking containers leak-side up to prevent the escape of liquid.
<b>Environmental precautions:</b>	Do not discharge into drains or rivers. Contain the spillage using bunding.
<b>Clean-up procedures:</b>	Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

## 7. HANDLING AND STORAGE

---

<b>Handling requirements:</b>	Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Avoid the formation or spread of mists in the air.
<b>Storage conditions:</b>	Store in cool, well ventilated area. Keep container tightly closed.
<b>Suitable packaging:</b>	Must only be kept in original packaging.
